

Job Titles and Descriptions

The following job titles and descriptions are considered transmission function employees as defined under the Federal Energy Regulatory Commission's (FERC) regulations.

Title	Job Description
Administrative Services Specialist	Performs skilled administrative support work providing a variety of administrative, program or technical operations, prepares and maintains a variety of detailed records, reports and files, assists employees with programs and projects, provides information, solves problems, responds to inquiries and performs related work as required.
Commercial Marketing Analyst	Responsible for the marketing and optimization of NJR Storage & Transportation assets. Provides related analytical and asset management support including providing coverage for day-to-day S&T commercial activity when needed. Supports the development of strategies for capacity marketing, and optimization. Provides after hours and weekend commercial support as needed. Supports S&T Leadership to advance project development for organic projects to FID, working to obtain anchor shipments to support such projects that achieve established target IRRs for capital investment, etc.
Compression Technician	Services, maintains, and repairs mechanical equipment (compressors, pumps, motors, etc.) used in natural gas transmission systems. The Compressor Technician maintains and operates natural gas (turbine and/or reciprocating) compressors, to ensure the continuous flow of natural gas to customers.
Compression Operator	Responsible for the operation of compressor facilities to ensure that they comply with DOT regulations and are available 24/7 to meet system pressure and flow requirements. The incumbent maintains good communication with Operations and Engineering to help address operational needs and provides assistance and support to Operations daily, ensuring safe, accurate and uninterrupted flow of natural gas through transmission systems. Maintains fleet of gas lift compressors to minimize downtime and maximize production and perform and track routine preventative maintenance on all equipment associated with compression (dehydrators, discharge scrubber, recycle scrubber, filter separators, emission systems etc.).
Contract and Administrative Assistant II	Provide administrative and contract support. Act as liaison between Storage and Transportation ("S&T"), pipeline, legal, finance and credit when establishing contractual documents. Ensure that contract processing follows established policies, tariffs and FERC compliance. Update EBB with contractual counterparties and credit limits.
Control Room Management	Provide oversight of the Control Room Management (CRM) Program to ensure compliance with Federal regulations. Responsible for the administration and

Specialist	documentation requirements of Federal Code 49 CFR Part 192.631 as it applies to Gas Control in LREC. Establish and maintain the Gas Control Training Program which provides for initial and continuous Gas Controller training. Oversees various support functions performed by Gas Controllers and other Control Room personnel related to Gas Supply.
Corporate Risk Analyst	Manage the credit process for the Company's Storage and Transportation businesses. Assist with management of corporate insurance program. Assist with management of corporate Enterprise Risk Management program. Maintain corporate policies and procedures.
Corrosion Technician	Provides a high level of technical support on the transmission system relating to corrosion control and pipeline integrity. Designs and maintains cathodic protection control facilities. Conducts internal and external specialized corrosion tests and maintains accurate reports.
Crew Leader – Instrumentation and Electrical	Responsible for performing all tasks associated with this position in addition to the scheduling and oversight of employees and activities related to the pipeline and associated appurtenance operation and maintenance activities to ensure that these comply with DOT regulations and are available 24/7 to meet system pressure and flow requirements. Provides budgetary input for forecasting and maintains expenditures within budgeted amounts. Assists with the maintenance and operation of a variety of tasks including 3rd party damage, corrosion prevention/mitigation, maintenance and corrective tasks on equipment such as pipelines, valves, valve actuators, instrumentation and electronic equipment, tubing and fittings, pig traps, and rectifiers. Makes decisions in the field to ensure work is being performed to Company standards and as per procedures. Recognizes, reports, and reacts to any abnormal conditions. Maintains good communication with Compression, I&E and Engineering to help address operational needs and provides assistance and support, ensuring safe, accurate and uninterrupted flow of natural gas through transmission systems.
Director Safety, Engineering, Integrity & Compliance	Responsible for transmission pipeline construction and maintenance projects, including overall engineering, corrosion control, procurement, and construction activities. Accountable for meeting project budgets and deadlines. Provides engineering and technical support for construction and maintenance areas. Ensures that the pipeline system complies with regulatory standards. Overall responsibility for integrity management plans. Completes and files essential system regulatory documentation. Evaluates, selects and applies standard engineering techniques, practices and procedures commonly employed in natural gas transmission pipeline construction and operations. Provides leadership, supervision, and development of assigned staff. Lead the Environmental, Health, Safety and Wellness efforts for NJR's S&T Operations; Partner with respective managers and their supervisors to develop strategic goals that ensure compliance, build a safety culture that mitigates and manages risk for all S&T Operations. Partner with plant personnel, commercial services, and scheduling to ensure safe, reliable and optimum service to customers. Responsible for maintaining compliance with pipeline safety regulations, industry standards and general engineering practices. Work with other departments to develop and promote

Manager Operations	Directs transmission pipeline operations in a fiscally efficient and effective manner while maintaining a safe and reliable system. Monitors and controls the movement of natural gas through pipelines in accordance with contractual requirements and consistent with system capabilities, operating characteristics and conditions, as well as within State, Local, and Federal Regulations. Provides engineering and technical support for measurement, compression and gas control areas. Provides supervision, leadership, and development of assigned staff.
Manager OT SCADA	Manages the operation, maintenance and security of an extensive and complex SCADA network, which allows the company to monitor, manage and control deliveries and operating pressures in its pipelines. Also manages the

	planning, development, installation, maintenance and security of the SCADA systems and related real-time systems, along with supporting legacy applications. Performs a variety of functions including supporting roles for the analysis, design, integration and implementation of real-time applications and communication networks. Works closely with Control Center Operations to maintain reliable and secure communications with remote PLCs that monitor and control various pipelines and ensures that reliable historical data is available for reports.
Manager Transportation Services	Manage transportation/ scheduling team responsible for shipper nomination processing, confirmations and allocations of all gas volumes on pipeline.
